SUBJECT: Call for Nominations and Broadening Assignments for the Fiscal Year 2020
President's Management Council Interagency Rotation Program, Cohort 18

SUSPENSE: Nominations due by December 13, 2019

ACTION: Review, disseminate, and submit nominations and broadening assignments

BACKGROUND/INTENT: This is a call for nominations and broadening assignments for the Fiscal Year (FY) 2020 Office of Personnel Management's (OPM) President's Management Council Interagency Rotation Program (PMC IRP). This is a six month interagency broadening opportunity for eligible high-caliber employees in the grades of General Schedule (GS) 13 through GS 15 or equivalent in the National Capital Region (NCR). Cohort 18 will run from Monday, March 30 through Friday September 25, 2020. Please submit all nominations and broadening assignments to Ms. Pamela Boteler by December 13, 2019.

For each individual nominee, Department of Defense (DoD) Components, Agencies, and Field Activities (Components) participating in the PMC IRP must also provide two broadening opportunities for other Federal Agency participants. Broadening assignments offer participants (i.e., Fellows) the opportunity to enhance and/or develop two or three primary Executive Core Qualifications. Assignments should provide opportunities such as a Senior Executive Service (SES) mentor, access to senior level meetings and/or a senior-level shadowing experience, and project/program/policy management experience.

The Department has been allocated seven slots, based on a projection of no more than 14 DoD offerings of rotational assignments. The Departments of the Army, Navy and Air Force may each submit a maximum of three nominees, with the condition that matching broadening assignments (6 assignments) will also be submitted. The Office of the Under Secretary of Defense for Intelligence and all other Fourth Estate Agencies and Field Activities may submit one nominee each, along with a matching broadening assignment. Nominations must be approved by a Deputy Assistant Secretary or equivalent senior level official. For Components interested in PMC IRP opportunities outside the NCR, managed by the Federal Executive Board, please contact either Ms. Jimmie Vaughn, or Ms. Pamela Boteler.
